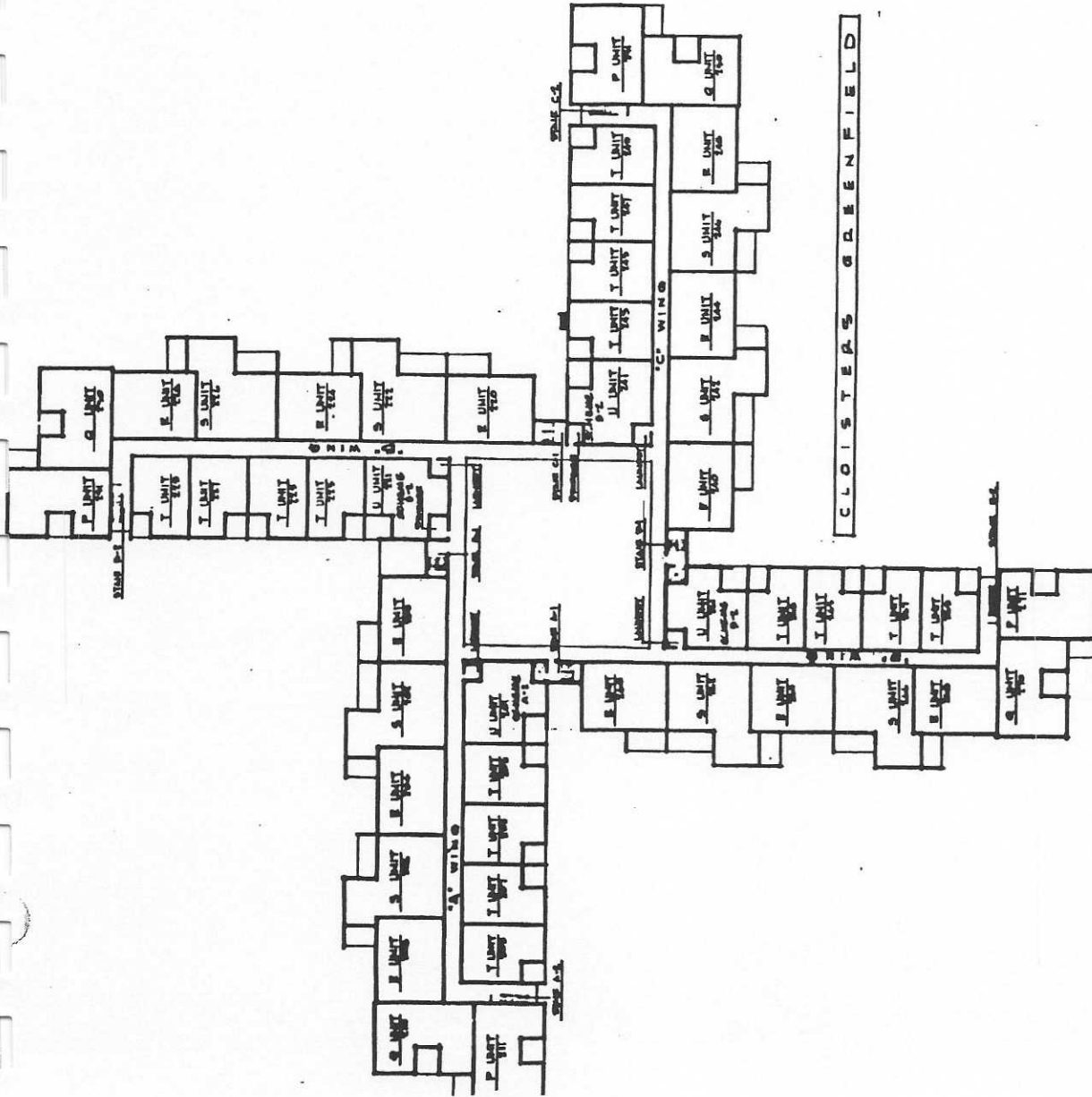

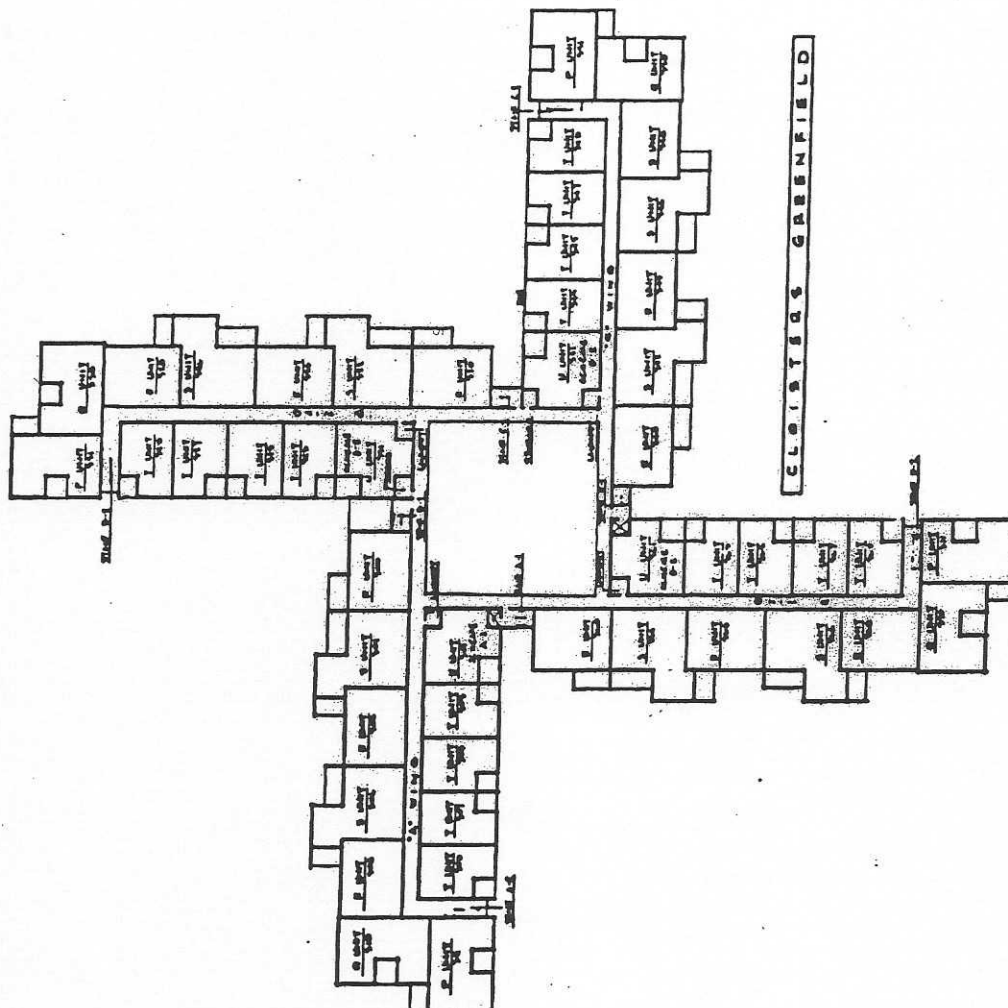

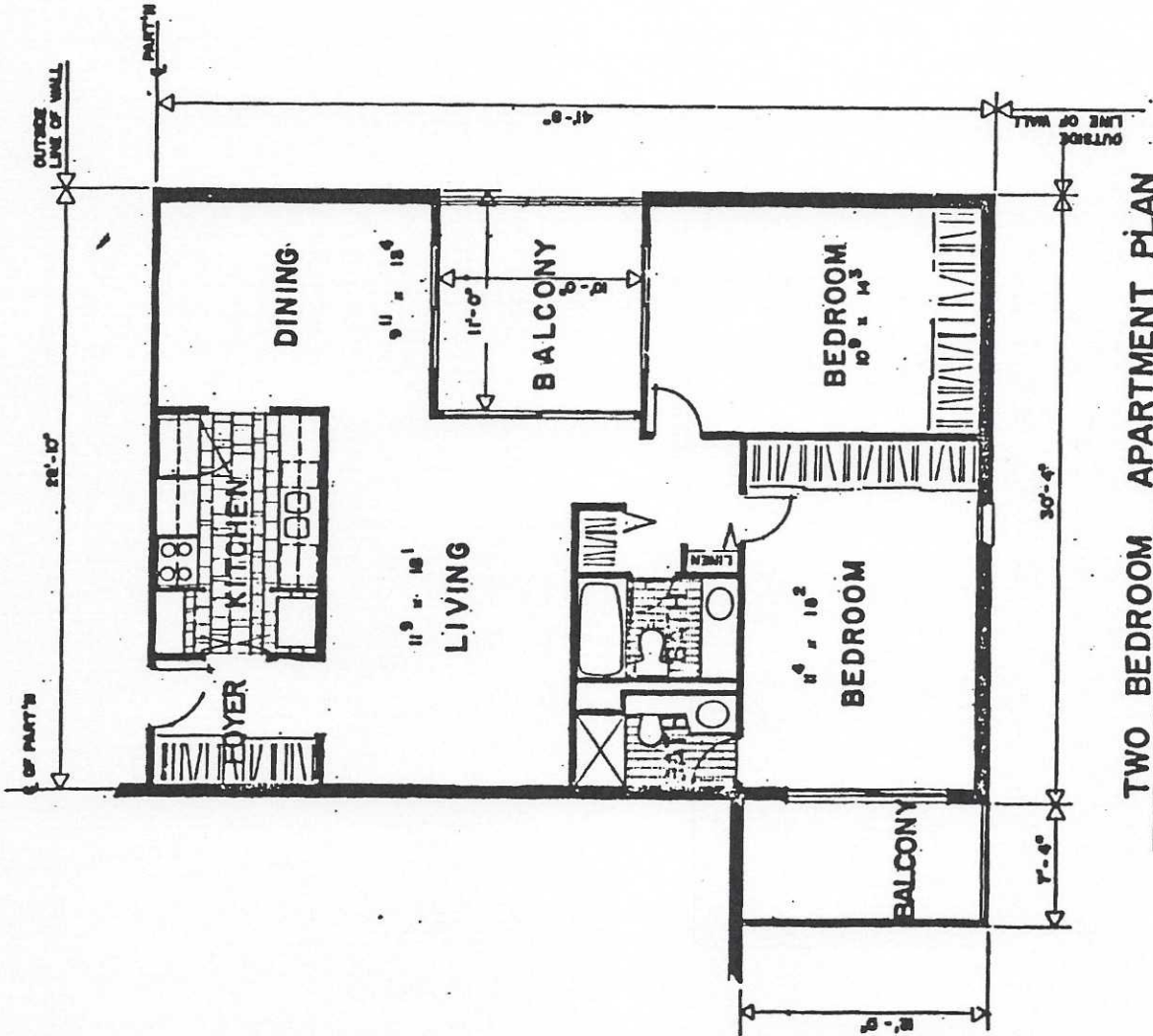

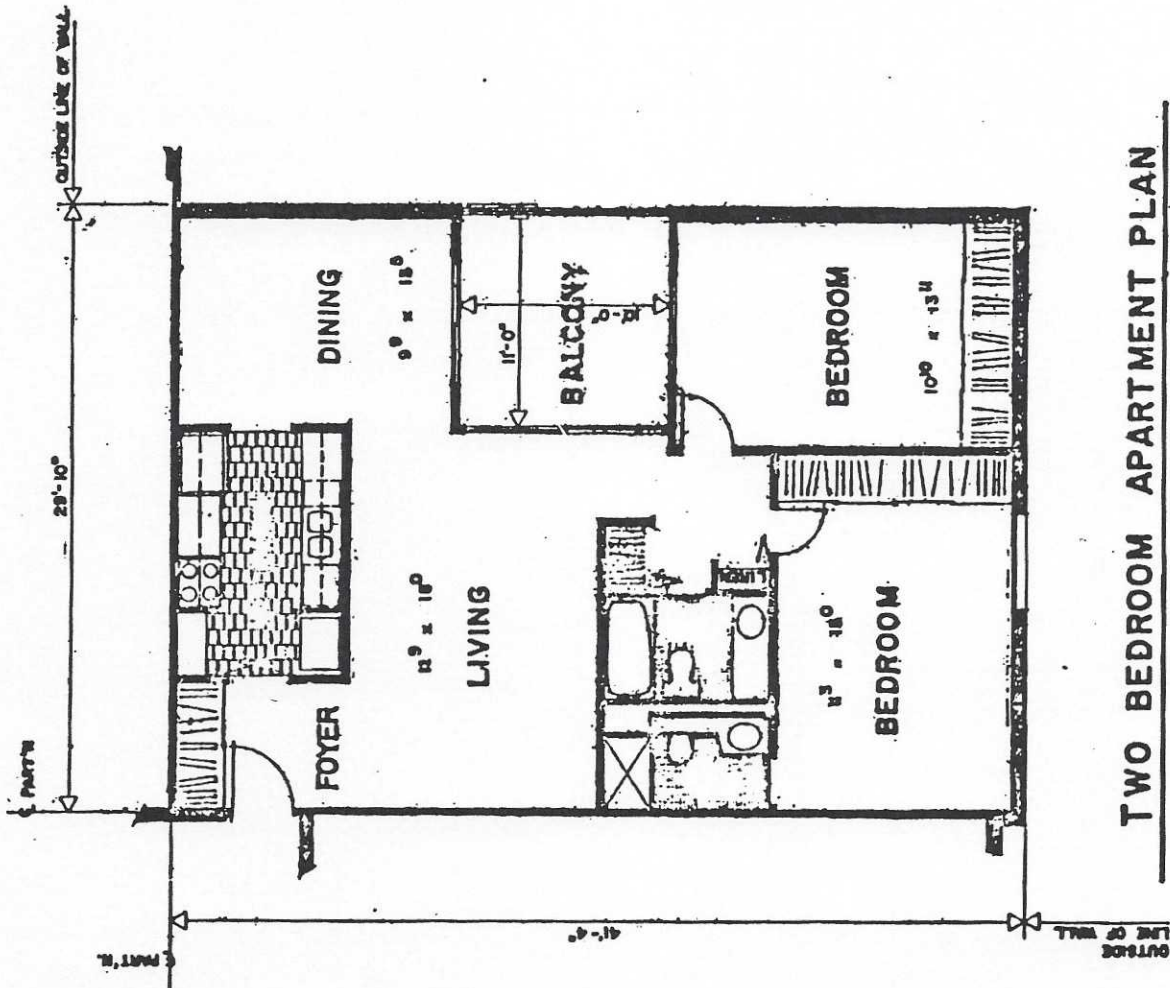


TWO BEDROOM APARTMENT PLAN

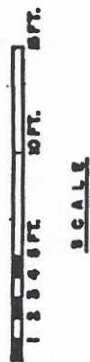

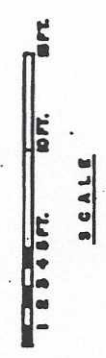
TWO BEDROOM APARTMENT PLAN
